



THE OKAMI Corporation member use agreement

THE OKAMI corporation association member use agreement is concluded about use of the accommodations of THE OKAMI affiliated hotel and ryokan between THE OKAMI (B) and _____(A) under the following provision.

Corporation-association-member-number

<Article 1> about the institutions which can be used

The institutions available for use are THE OKAMI affiliated hotel and ryokan in Izu area.

(About an affiliated hotel and ryokan, refer to the sheet attached.)

<Article 2> about accommodation fee

An affiliated hotel and ryokan set up a special price, respectively.

Please ask for details to each hotel and ryokan directly. For corporation members, THE OKAMI affiliated hotel and ryokan will directly contact the member for information via fax etc.

<Article 3> Discount candidates

The employee of the company and accompanying family or friends. However, if not accompanied by an employ, one will not be considered a candidate for discount.

<Article 4> about payment

A user will pay directly to the institution he/she uses, at the time of check-in or check-out

<Article 5> about reservation

Please ask directly to the affiliated institution.

Please declare your company's name, a corporation member number, guest's name and the guest's phone number (a fixed-line telephone or a cellular phone) at the time of reservation.

<Article 6> terms of the usage of the institutions

On the occasion of stay, we serve according to the hotel and ryokan's article. Please present your name card or and employee certificate at the time of check-in.

<Article 7> about cancellation and making changes

Please inform a hotel or ryokan that you made a reservation.

Cancellation and change fee will be charged according to the policy of hotel or ryokan that you had reserved, when the user makes a cancellation or a change for his convenience. However, the above don't apply if the cancellation or the change is due to one of the following reasons.

1. A convulsion of nature or for a reason associated to it.
2. For the convenience of the affiliated institution.

<Article 8> Terms of agreement

1. Trouble about this agreement between persons concerned will be consulted as to how to settle. THE OKAMI will take no responsibility.
2. Whenever a question about this agreement is called, THE OKAMI and the corporation member are to consult with each other.

<Article 9> Terms of contract

For one year (April 1, 2007-March 31, 2008)

<Article 10> Cancellation of the contract

This contract may be cancelled for THE OKAMI or corporation member's occasions. If there is no use of institutions within a year, THE OKAMI may make an arbitrary decision to cancel the contract.

To certify this agreement, two copies of this contract will be drawn. THE OKAMI and the corporation member are to sign, seal and keep one copy of this contract each.
